



Statutory Stewardship





- The Seeds contained in the packets sold under US Agriseeds Brand must not be used for feed, food or human consumption. The seeds are treated with Poison
- The seeds of the container are only for agriculture planting purpose and cannot be used for edible oil or any other human/feed consumption. Store away from feeds and other foodstuffs
- Dispose of seed packaging in accordance with local requirements. Exposed treated seed may be hazardous to birds. Dispose of all excess seed and seed packaging by burial away from bodies of water
- Harmful if swallowed, absorbed through skin or inhaled. Avoid breathing vapor or spray mist. Wash thoroughly with soap and water after handling
- Remove contaminated clothing and wash before reuse. If swallowed: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow
- DO NOT induce vomiting unless told to do so by a poison control center or doctor. DO NOT give anything by mouth to an unconscious person. If on skin or clothing, Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 to 20 minutes
- Call a poison control center or doctor for treatment advice. If Inhaled: Move person to fresh air. If
 person is not breathing, call 108 for an ambulance; then give artificial respiration, preferably by
 mouth-to-mouth, if possible
- Have the product container or label with you when calling a poison control center or doctor or going for treatment

Results will vary due to local growing, soil and weather conditions. Growers should evaluate data from multiple locations and years whenever possible.
